 A. Apex Goal was \$50,000, actual profit was \$47,945. 1829 pledges. 445 students participated. 186 leadership lessons taught. 300 hours provided by Apex. 1479 donations received from 51 states. Funds this year will go to general fund. In past years teachers received 10% of funds raised by the classroom. This year, reimbursement per teacher was increased to \$250 equally distribute 	Jordyn Ybarra

funds across classrooms. Additional funds were also added to cover all field trip transportation costs. Top 5 teachers will receive Amazon gift cards. Apex cut is 42%. This covers all hours, leadership lessons, and donation platform provided by Apex. Discussion around how Apex handles kids who do not earn prizes to ensure kids don't feel left out. B. Open house is Wednesday May 8 Keri will send communication to PTO delegates with suggestions Would like to bring back door decorating - Paraprofessionals and other staff members will all be included in the general teacher appreciation week Fencing Update Ms. Harrington has met with the district and no modifications will be made, including adding any plants on the exterior of the fence line. Request for explanation on why Ditmar was allowed to put up a screen on the fence. **Entire Board** Request for disclosures regarding data security cameras on campus. Abi has made a FOIA request for more information on the winning bid. Response was more information would be provided on or around April 15. Ms. Harrington is currently the only individual on the school site that has access to view the

cameras.

- Request for what happens if someone approaches the fence. Ms. Harrington shared that if a noon duty observes activity (loitering) the noon duties are to radio the front office, and Ms. Harrington would determine the course of action.
- Jennifer Williams shared experience as a noon duty of a man with dog that approached the fence and the kids were petting the dog through the fence.
- Request for reason why the privacy screening was not replaced. Ms. Harrington shared that line of sight outside of school boundaries is important.
- Response from Mike Blessing, area district board representative has requested one year of documented instances before taking action.
- Fencing was replaced to reduce the size of the gaps in chain link to make it less scalable.
- Kids are have been observed climbing the back gate 10 minutes before school is released with no supervision. Back gate is currently left unlocked by BASE program. Back gate is otherwise locked, and exception was made by the fire marshal and all adults on campus carry a key.
- Ms. Harrington mentioned increased measures to lock gates during school hours. Per policy, the campus must remain open to public access.
- Jordyn requested support from Ms. Harrington and Ms. Goss to support voicing parental concerns.
- The petition has achieved 235 signatures. New link on the PTO website documenting the situation and attempts to resolve.
- Request to Ms. Harrington and Ms. Goss to help document incidents.
- Request as to why a fence was installed that is contradictory to the facilities master plan.
- Next step if school site administration cannot assist, parents should attend the next school board meeting.
- Request to Ms. Harrington to put requests to district in writing.
- Ms. Harrington has agreed to document incidents for board member review.
- Ms. Harrington states that the supervisor has responded to community emails.
- District communication can be discoverable via CA public records request.
- Uniform complaint form will be submitted to the district.
- Request to make parents aware of incidents at the fence line. Abi has shared some of the incidents that she has been made aware of on the page linked on the PTO website.
- Currently no incident reports are made by the school except in the case of a safety incident. A safety incident would be defined by the district.
- A large turnout at a district board meeting could result in the item being agendized on a future district meeting.
